

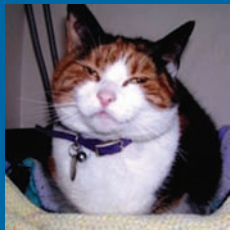
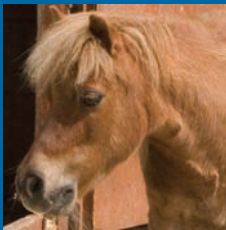

What happens to unwanted animals that have no where to turn for help? Some of the lucky ones are found safe and secure accommodation with the National Animal Welfare Trust. Our four re-homing centres offer hope and a bright future to a wide variety of animals.

We aim for our animal's stay with us to be as brief as possible in order that they can begin their new lives as quickly as possible. That is why our sponsorship scheme specifically supports the animals' accommodation. In this way we can ensure that as many animals as possible benefit from your gift. Over the course of a year for example a single kennel could house up to eight separate dogs and so your gift will go that much further...

From as little as £1 per week you can help us to provide appropriate and welcoming accommodation. From a cat pen and dog kennel to a green pasture for a goat, and runs for the rabbits and guinea pigs. Until the Trust can find these animals loving new homes, we can ensure their wellbeing together.
